The City Manager's proposed FY 2013/2014 budget is based on a millage rate of 7.9900. This proposed tentative millage rate is the same as the rate levied in FY 2012/2013 and reflects a 4.8% increase from the rolled back rate of 7.6243.

Staff is proposing that the Commission adopt 7.9900 (the current millage) as the tentative proposed millage rate for FY 2013/2014.

Attached is Resolution No. 2013-23, establishing the tentative proposed millage rate at 7.9900. The adopted rate will be communicated to the Property Appraiser and used in the Notice of Proposed Property Taxes (TRIM Notices) issued to Deltona property owners in late August.

WHEREAS, the Volusia County Property Appraiser has certified to the City the taxable value of all property within the City for the 2013-2014 fiscal year; and

WHEREAS, it is the responsibility of the City to advise the Property Appraiser of its proposed millage rate, of its rolled-back rate, and of the date, time, and place at which a public hearing will be held to consider the proposed millage rate and the tentative budget;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. A proposed millage rate of 7.9900 mills is hereby adopted for the 2013-2014 fiscal year.

Section 2. The rolled-back rate for the 2013-2014 fiscal year is 7.6243 mills.

Section 3. A public hearing will be held on September 3, 2013 at 6:30 p.m., or as soon thereafter as may be heard, at Deltona City Hall, 2345 Providence Boulevard, Deltona, Florida, to consider the proposed millage rate and the tentative budget.

Solid waste assessments for services, facilities and programs in the amount set forth in the assessment roll as herein approved, are hereby levied and imposed on all parcels of assessed property described in the assessment roll.

Section 4. Approval of Assessment Roll. The assessment roll attached hereto is approved and adopted and shall be certified and delivered to the Tax Collector prior to September 18, 2013, for collection using the uniform method of collection.
