City to celebrate Fla City Gov't Week with photo contest

Sept. 30, 2016— The City of Deltona plans to celebrate Florida City Government Week with a photo contest. Amateur and professional photographers of all ages are invited to enter their best images celebrating “My City: I’m Part of It, I’m Proud of It” Oct.1-22. Florida City Government Week is officially Oct. 16-22. Entering is easy, free and by e-mail. Criteria: The mission of this contest is to celebrate Deltona and to showcase our residents and community pride. All photos must be taken within our City limits. Photos submitted before Oct. 17 will be displayed during the Oct. 17 Commission meeting and at City Hall throughout Florida City Government Week. Judging will be completed following Florida City Government Week and the winner announced at a following Commission Meeting. The winner will be featured on the City’s Web site, on the City of Deltona Facebook page and also in the City newsletter.

Image Requirements: Eligible images from a digital camera set at no less than 3 mega pixels high resolution or digitally scanned if from a non-digital camera must be either JPG or PNG digital format at a file size between 3 megabytes and 9 megabytes at 300 dpi (dots per inch) or sufficient resolution to print at 8 by 10 inch size without loss of quality.

Rename Your Files: File names generated by the digital camera or scan must be renamed “MyCity” followed by the last name of the contestant, first name of the contestant and a short title without using any spaces, underlines or dashes. For instance, if Wendi Jackson entered a photo of Thornby Park, she would name the photo entry MyCityJacksonWendiThornby.jpg or MyCityJacksonWendiThornby.png.

Submit Your Photos By Email: Entering is easy and free! Limit up to six entries/emails per contestant. Attach only one image file per email and send to: wjackson@deltonafl.gov. On the email subject line, include MyCity and your name. In the body of the email, include:

1. **The first and last name of the contestant**
2. **A contact phone number**

3. **A contact email address**
4. **The location where the photo was taken**
5. **The date the photo was taken**

Entry Agreement: By submitting entries, the contestant acknowledges and agrees to the terms of the contest Entry Agreement. In submitting the attached photo(s) to the City of Deltona and participating in the City of Deltona Photo Contest I (we), (CONTESTANT), hereby warrant and agree to the following:

- CONTESTANT warrants to the City of Deltona that he/she has lawful ownership rights to the PHOTO and acknowledges that once submitted, the PHOTO becomes the property of the CITY.
- The PHOTO is the result of CONTESTANT'S sole artistic efforts unless otherwise stated above as collaboration.
- Except as otherwise disclosed in writing to CITY in this submittal form, the PHOTO is unique and original and does not infringe upon any copyright or patent.
- The PHOTO is free and clear of any lien. Except for title and possession, pursuant to the Copyright Act of 1976, CONTESTANT will retain the copyright and all other rights in and to the PHOTO. The CONTESTANT grants to CITY an irrevocable and non-exclusive worldwide license to reproduce, to distribute, and/or to display two or three dimensional reproductions of the PHOTO in any manner whatsoever relating to any CITY publication or event, including, without limitation.
- Public display as well as reproduction on CITY items, such as print ads, postcards, posters, brochures, applications, television programs and the City web site.
- In addition the CITY will include CONTESTANT'S name somewhere on the document where the photo is used.
- The CITY may alter images of the PHOTO as necessary to fit into reduced or enlarged format sizes.
- The CITY may use the PHOTO on CITY merchandise and commercial items which may be sold for fundraising purposes.

HOLD HARMLESS: CONTESTANT agrees to release CITY, its agents, officials, employees, and volunteers from and against all liability, including copyright or patent infringement claims or causes of action, arising out of this Agreement and claims arising from CONTESTANT'S participation in the City of Deltona Photo Contest.
