NEW TRASH RULES OCTOBER 1ST



Recycling: Residents may place unlimited recycling at the curb, as long as it's in a compatible bin and labeled "RECYCLE." Recyclables cannot be placed in bags.

Items that can be recycled include all colors of glass bottles, newspapers, magazines, mixed office paper, aluminum and steel cans, phone books, junk mail, gift boxes, cereal boxes & pizza boxes (no liners) and plastics with recycling code numbers "1" through "7" (**no styrofoam or plastic bags**). With single stream recycling, large cardboard boxes will be collected and do not have to be broken down.

Tires: You may place up to eight passenger and truck tires per year at the curb for pick-up. Oversize truck tires require a special pickup and additional fees may apply.

Hazardous Materials: Household hazardous waste materials include not only motor oil and batteries but also pesticides, gasoline, paint, thinners and solvents, pool chemicals and others. These materials can be toxic to the environment and potentially contaminating to our water supply, yet these products are common in our homes and garages. These items should not be placed in your garbage bin. Please deliver hazardous materials **FREE OF CHARGE** to the West Volusia Transfer Station (3151 E. Highway 44) from 7 a.m. to 5 p.m., Monday-Friday and from 8 a.m. to 3 p.m., Saturdays. Watch for special Hazardous Waste amnesty pays for special drop-off locations.

**NEW TRASH RULES
STARTING OCTOBER 1ST 2018**

The City of Deltona provides garbage service through a contract with Waste Pro of Florida, Inc., a private collection contractor with offices throughout Central Florida. Waste Pro will be transitioning, from recycle and automated trucks to rear load trucks. They anticipate this occurring by December 1st, 2018

The resident will see three (3) trucks on garbage day:

The automated truck will pick up the Waste Pro toter and a rear loader will pick up additional cans and bulk items. A separate rear loader will then pick up recycling and cardboard boxes. These trucks will be labeled RECYCLE MATERIALS ONLY.

All Materials meant for collection (household garbage, bulk, recycling or yard waste) must be at the curb by 6 a.m. on the proper pick-up day and removed no later than 9 p.m. on collection day. Service will still be one day a week. Do not place bins or bulk items within three feet of objects such as mailboxes, parked vehicles, fire hydrants, trees or poles.

Customers will continue to use their Waste Pro garbage toters. New residents who do not have a Waste Pro toter, should call (386) 574-0723.

Household Garbage: You may have additional containers that will be picked up but they must have two handles and a lid - for wheeled containers there is a weight limit of 100 lbs. For non-wheeled containers they cannot weigh more than 50 lbs.

All garbage must be contained in bags and may not be loose in the container. If you have loose household waste in the container and that waste when dumped flies everywhere or the bags break- the contractor will make every effort to pick-up and clean the area. If there are repeated occurrences the contractor may report that to the City's consultant so that an acceptable solution can be attained.

Bulk Trash: Including sinks, countertops, doors, shelving, fencing) may also be placed at the curb for pick-up. This includes white goods like stoves - also mattresses, furniture, etc.

Construction debris: is not considered bulk waste, from remodeling projects will not be picked up unless scheduled and additional fees will apply.

Move-outs & Abatements: If garbage cans and/or other trash is placed at the curb outside of the normal pick-up schedule then the City will deem the waste to be a public health or safety hazard placed in the city right-of-way and it shall be declared a nuisance. The City is authorized to remove the nuisance, after posting the property with a notice requiring the property owner to abate (remove) the garbage & trash within 24 hours of the posting of the notice. The property owner shall be responsible for any costs incurred by the city for abatement of the nuisance and a lien shall be imposed on the property. This same process applies to yard waste, recycling and any other garbage that is left on the public right of way.

Yard Waste: This includes grass, leaves, shrubs and tree trimmings only. Each residential property is entitled to place up to fifteen bags of yard waste or bundled piles of limbs. Palm fronds and limbs may be neatly stacked and are required to be bundled (no piles will be picked up).

Limbs should not exceed five feet in length, six inches in diameter or fifty pounds. Excessive yard waste requires a special pick up and fees may apply.

Please do not mix yard waste with your household waste.
